is hereby confessed and acknowledged, do *s* by these presents grant, bargain, sell, remise, release, alien
and confirm unto the said part *y* of the second part, and to *his* heirs and assigns

Forever, *All that certain piece or parcel of land situated and being in the*
Town Ship of Holland, County of Ottawa and State of Michigan and parti-
cularly known and described as a piece commencing at the North
East Corner of North West quarter Section Thirty six (36) Town Six (6) South Range fifteen
1st West and running thence South Seventy four rods (74) thence
West Twenty one (21) rods thence North Seventy four rods
thence East 25 rods and thence to place of beginning and con-
taining ten acres of land.

Together with all and singular the hereditaments and appurtenances thereunto belonging, or in
anywise appertaining.

To Have and to Hold the said premises as described, with the appurtenances, unto the said
party of the second part, and to *his* heirs and assigns, forever. And the said part *y* of the
first part, for *herself and her successors* heirs, executors, administrators and assigns does cove-
nant, grant, bargain and agree to and with the said part *y* of the second part, *his* heirs and
assigns, that at the time of the ensembling and delivery of these presents, *She is* well
seized of the above granted premises, in Fee Simple. That they are free from all incumbrances whatever;
and that *She* will, and *her successors* heirs, executors, administrators and assigns shall
Warrant and Defend the same against all lawful claims whatsoever.
