Witnesseth, That the said parties of the first part, for and in consideration of the sum of Fifty Dollars

to them in hand paid by the said party of the second part, the receipt whereof is hereby confessed and acknowledged, do by these presents grant, bargain, sell, remise, release, alien and confirm unto the said party of the second part, and to his heirs and assigns

Forever, All the right title and interest in that certain tract or parcel of land which is situated in the City of Holland County of Ottawa and State of Michigan. And further described as the West 1/2 (B) 1/2 of lot number three (3) in Block number Sixty Nine (9) of the said City of Holland, according to the recorded plat thereof on record in the Village of Holland, in the register office at Grand Haven Michigan

Together with all and singular the hereditaments and appurtenances thereunto belonging, or in anywise appertaining.



To Have and to Hold the said premises as described, with the appurtenances, unto the said party of the second part, and to his heirs and assigns, forever. And the said parties of the first part, for themselves, their heirs, executors, administrators and assigns do covenant, grant, bargain and agree to and with the said party of the second part, his heirs and assigns, that at the time of the ensembling and delivery of these presents, they are well seized of the above granted premises, in Fee Simple. That they are free from all incumbrances whatever; and that they will, and their heirs, executors, administrators and assigns shall

Warrant and Defend the same against all lawful claims whatsoever.
