

# This Indenture, Made the Twenty Ninth

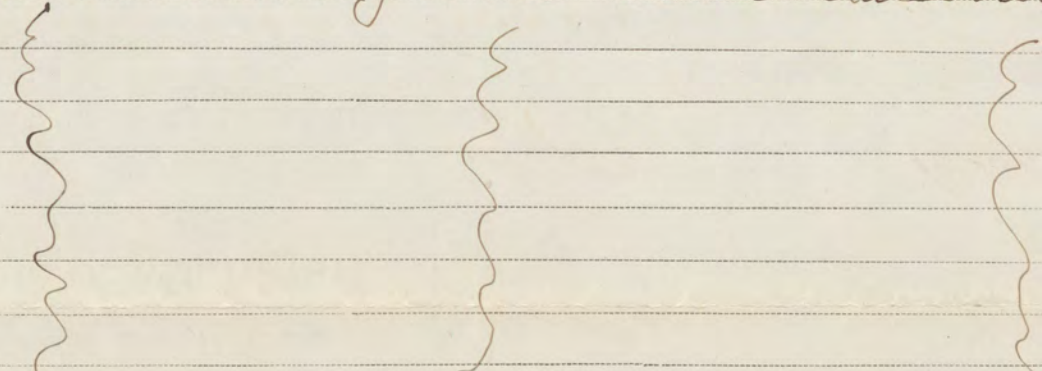

dou by these presents, grant, bargain, sell, remise, release, alien and confirm unto the said part y of the second  
part, and his heirs and assigns, **Forever**, All the following certain piece s or parcel s of  
Land, situate and being in the Township of Holland County of  
Ottawa and State of Michigan, particularly

known and described as follows, to wit: The North East-  
quarter of the South West quarter (NE 1/4 of SW 1/4)  
in Section Twenty Eight (28) Township  
Five North Range Fifteen West, except  
the right of way deeded to the Michigan  
Lake Shore Rail Road, and a piece  
of land laying in the North East corner  
of said description, bounded on the East-  
by the East-line on the North by the North  
line of said description, on the West by  
the bottom of the Brook, and on the South  
by the Michigan Lake Shore Rail Road
