do hereby these presents, grant, bargain, sell, remise, release, alien and confirm unto the said part y of the second
part, and his heirs and assigns, **Forever**, All the following certain pieces or parcels of

Ottawa and State of Michigan, particularly

known and described as follows, to wit: The North East quarter
of the South East quarter, and the East
half of the North East-quarter all in

shall **WARRANT AND DEFEND** the same against all lawful claims whatsoever,

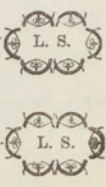
