



This Indenture, Made this fourteenth day of November in the year of our Lord one thousand eight hundred and Seventy one

BETWEEN Wijbe Dijkema, Dirk Medema, John Ten Have, Hendrik van Eyk, Bernardus Ledebier, Isaac Cappon, Jacob van Putten and Ojbertus van der Ven Harbor Commissioners of the City and Townships of Holland and their successors in office of Holland in the County of Ottawa and State of Michigan of the first part, and Dirk B. K. Van Raalte of this same place of the second part,

Witnesseth, That the said parties of the first part, for and in consideration of the sum of Eighty Dollars

to them in hand paid by the said party of the second part, the receipt whereof is hereby confessed and acknowledged, do by these presents grant, bargain, sell, remise, release, alien and confirm unto the said party of the second part, and to his heirs and assigns

Forever, all of that certain piece or parcel of Land situated in the County of Ottawa and State of Michigan known and described as follows: The North East quarter of the South East quarter of Section numbered twenty three (23) in township numbered Six (6) north of Range numbered Fifteen (15) West; containing, according to the United States Survey, Forty acres, be the same more or less.

Together with all and singular the hereditaments and appurtenances thereunto belonging, or in anywise appertaining.

To Have and to Hold the said premises as described, with the appurtenances, unto the said party of the second part, and to his heirs and assigns, forever. And the said parties of the first part, for themselves and their successors heirs, executors, administrators and assigns do covenant, grant, bargain and agree to and with the said party of the second part, his heirs and assigns, that at the time of the ensembling and delivery of these presents, they are well seized of the above granted premises, in Fee Simple. That they are free from all incumbrances whatever; and that they will, and their successors in office executors, administrators and assigns shall Warrant and Defend the same against all lawful claims whatsoever.
